ADDITIONAL INFO: The City of Tempe issued a Request for Proposal to establish contracts for vehicle and equipment repair parts. A total of thirty-four responses were received. A committee comprised of Fleet Services and Procurement staff met and reviewed the submitted proposals. The proposal was broken down into twelve categories of use with a majority of vendors submitting for multiple categories. It is the recommendation of the committee to issue contracts to the highest rated firms as noted above to provide a sufficient variety and availability of vehicle repair parts to maintain the City's diverse fleet composed of 1,200 units. Fleet Services will proactively monitor pricing among awarded firms and utilize the firm providing the best pricing and delivery for a particular item.
