RESOLUTION NO. 2009.05

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, AMENDING THE JULY 1, 2008-JUNE 30, 2009 MEMORANDUM OF UNDERSTANDING BETWEEN THE TEMPE SUPERVISORS' ASSOCIATION AND THE CITY OF TEMPE TEMPORARILY SUSPENDING THE MARKET ADJUSTMENT PROVISIONS SET FORTH IN ARTICLE 6.2.B

WHEREAS, the City of Tempe ("Tempe") and Tempe Supervisors' Association ("Union") have entered into a Memorandum of Understanding ("MOU") for the period of July 1, 2008 to June 30, 2009; which was approved by the City Council on July 22, 2008, and

WHEREAS, Article 2.2 of the MOU contains a reopener provision in the event of a "Fiscal Crisis" which requires the parties to meet and confer in an effort to reach an agreement on the reduction of benefits to Union members; and

WHEREAS, Tempe believes it is currently experiencing conditions that meet the MOU's definition of a "fiscal crisis" as provided in Article 2.2; and

WHEREAS, the parties have agreed to forgo the option to reopen the MOU, and instead come to an agreement to suspend certain benefit provisions of the MOU as set forth herein.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, as follows:

That the Memorandum of Understanding between Tempe Supervisors' Association and the City of Tempe for the period of July 1, 2008 to June 30, 2009, is hereby amended, as described in the following paragraphs:

The Market Adjustments provision set forth in Article 6.2.B of the MOU shall be temporarily suspended and voided until such time that the "fiscal crisis" subsides or the MOU terminates.

The determination as to when the "fiscal crisis" subsides and the Market Adjustments are reinstated shall be made by the mutual consent of the parties.

Any alleged breach or impasse of this Agreement shall be resolved as provided for in the parties' MOU.
