Held the **introduction and first public hearing** for a Zoning Map Amendment with a Planned Area Development for 2150 SOUTHERN CAMPUS MASTERPLAN, located at 2150 E. Southern Avenue. **A second public hearing is scheduled for April 9, 2009.**

COMMENTS: (PL080282) (Thomas Sawner, Educational Options, property owner; William Sawner, applicant) consisting of a phased mixed-use development with a charter school, a private school, assembly space for performances, recreational uses, commercial and residential uses initially located within six existing structures and eventually built into five new structures with building heights of 48 to 70 feet tall. Completed development will consist of approximately 192,156 s.f., on 8.87 net acres, located at 2150 E. Southern Avenue in the R/O Residential Office, CSS Commercial Shopping and Service and R1-6 Single Family Residential Districts. The request includes the following:

ZON08011 – (Ordinance No 2008.66) Zoning Map Amendment from R/O Residential Office, CSS Commercial Shopping and Service and R1-6 Single Family Residential districts to MU-2, Mixed-Use, Medium Density District.

PAD08019 – (Ordinance No 2008.66) Planned Area Development Overlay to define setbacks: zero-foot front and street side, 30-foot side and rear, with an actual building location 80 feet from the rear; building height to be 42 feet at rear of lot and 60 feet at front of lot; maximum lot coverage 40% and minimum landscape area 15%; maximum density not to exceed 9 dwelling units per acre, with a maximum of 80 residences.

APPLICANT'S PRESENTATION

Eric Emmert, Tempe, Vice President, Door and Policy Group, contracted with the Applicant to handle public outreach on this case. An agreement is in place with the neighborhood. The Applicant and neighbors have gone through many neighborhood meetings, there have been many team meetings with the neighborhood and many meetings have been held with individuals in the neighborhood. The agreement was provided to Council earlier this week.

Joe Salvatore, Architekton, summarized the site plan to provide project information.

- The site is the Tri-City Baptist Church site at the northwest corner of the 101 and Southern Avenue.
- The site does not include the AM/PM Mini-Mart or the Landis property next door.
- Intentions are to build the project in three phases.
 - The existing site is composed of the sanctuary building, an existing gymnasium building (which eventually will be the only building remains on this campus), and several smaller buildings around the perimeter of the site. Educational Options will operate on the facility as it exists for a period while plans are being developed for their future buildings.
 - The second phase would involve removal of some of the buildings and building two new buildings to support their education and office functions. They will also build some classroom spaces around the existing gymnasium building to create a quad down the center for more collegial type of environment.
 - The third phase will see two new buildings along Southern Avenue and the Price Road interchange.
- The surrounding neighbors in the Shalimar neighborhood have been involved in the adjustment and tweaking of plans to develop a regime of building heights and setbacks that are being presented as the PAD. He showed the buildings heights and setbacks for the total build-out phases.
 - An 80' no-build zone is provided around the perimeter to buffer any development from the neighbors. From the neighbors' perspectives, it will be build up toward the higher points of the buildings as far away from their property lines as possible.
 - From the west, there is the 80' no-build zone along Southern, then it graduates upwards to a 20' height, 40' height, 55' height, up to a 65' height, plus mechanical screening along Southern.
 - Moving further toward the north, there is the 80' no-build zone, a 32' zone, a 42' zone, and then a 48' zone.
 - From the north, there is a 35' zone, mostly to accommodate the existing gymnasium building and then the 42' zone and the 48' zone.
 - Toward the Price Road side from the north, there is the 80' no-build zone, and again the 20', 40' 55' and 65' limitations.
- Extensive reviews have been done of the site sections to check the building heights and working in coordination with the neighborhoods. An 8' solid masonry wall will be built along the property lines, with a double row buffer of trees.

Councilmember Mitchell asked if the heights run with the land.

Lisa Collins responded that the entitlements and PAD conditions run with the land regardless of the ownership. Whoever owned this property would have to build in conformance with the plans before Council.

Jeff Sawner, President of Educational Options, stated that he is excited that Educational Options will have a home in Tempe. He thanked all City staff who have helped, and extended a special thanks to the neighbors. A number of productive meetings have been held over the past nine months. Everyone has worked together and it has worked well.

The neighborhood worked hard with Educational Options over many months and it was a breakthrough that got this to where it is today. The importance of what we were able to negotiate is that 80% of the neighborhood supports this. Educational Options supports this or less (less height, further away from the neighborhood, or

less mass). It is important to the neighbors that this be locked in and with Council's help make sure that we move forward with this plan.

6. PUBLIC APPEARANCES

UNSCHEDULED PUBLIC APPEARANCES:

Ed Mitchell, Tempe, read a statement from the San Antonio Disability Etiquette Handbook: "Disability is a condition caused by an accident, trauma, genetics, or disease which may limit a person's mobility, hearing, vision, speech, or mental function. Some people with disabilities have more than one. A handicap is a physical or attitudinal constraint that is imposed upon a person regardless of whether that person has a disability or not." Part of his journey over the last couple of months is understanding that difference. Tempe is a terrific city. Part of his learning curve was to sit down with someone who is visually impaired and talk about how a service dog helps her cross a street. When she arrives at a street, the dog will stop at the curb. Her responsibility is to use her foot to feel if there is a curb or cut-out.

Her responsibility is also to determine when the light has changed. Once she has determined the light has changed by the flow of traffic or because of some other factor, she then tells the dog to proceed. The dog proceeds in the crosswalk, walking between the white lines. Downtown Tempe has eliminated many of those crosswalks and as a result, the City has created a handicap for a person with a disability. A budget is the best way to determine a City's priorities. The priority for disability in the City is a part time employee. He is concerned that there are people in every department interacting on disability issues but they rarely communicate with the ADA Specialist. That needs to be addressed. Sometimes a great idea comes to a department, and the department decides not to do it. The lock box program for seniors and the disabled, a program active in Scottsdale, Fountain Hills and Chandler, was refused in Tempe. This program would allow fire and police departments to use a key to access a lock box to enter a disabled person's or a senior's home. His hope is to reactivate that discussion. Also, the Phoenix "Save our Spaces" program needs to be investigated. It is difficult to find accessible parking spaces because many times they are utilized by non-handicapped or delivery trucks and the disabled cannot park there.

Mike Griffiths, President and Chief Operating Officer of Veolia, thanked Council for their support and confidence on behalf of their employees in Tempe. Veolia is a company that cares about the passengers and is dedicated to the safety.

7. CURRENT EVENTS/COUNCIL ANNOUNCEMENTS/FUTURE AGENDA ITEMS

- Councilmember Mitchell reminded everyone about the 7th Annual Joseph P. Spracale Education Awards on Saturday, April 11th, at the Fiesta Inn Resort and Conference Center. More information is available at www.tiefoundation.com. Part of that event honors teachers and educators in the community. That award goes to **Alejandro and Josie Arredondo**, life-long residents of Tempe who instilled in their children that anything could be accomplished in the United States. They also believed that education was the key to success. They had six sons: Dan, Joe, Alex, Hank, Rick and Ben. All six brothers have earned degrees in education at ASU. In total, the Arredondo family has contributed over 350 years of service in education as teachers, principals, administrators, support staff, and school board members.
- Vice Mayor Ellis added her congratulations to Councilmember Arredondo and his family.
- Councilmember Arredondo extended his thanks, and added that to have parents like his was truly an honor. From their father, they learned the work ethic, and from their mother, the importance of education. Receiving the Joseph P. Spracale Education Impact Award is an honor. Everyone should have met a Joe Spracale in their lives. He reminded everyone about the Tempe Art Festival this weekend and the Tempe Music Festival next weekend.
- Councilmember Navarro added his congratulations to Councilmember Arredondo and his family. Mr. Spracale has also done so much for this community
- Councilmember Shekerjian thanked Judge Arkfeld, Fire Chief Jones, and Police Chief Ryff for meeting with the Polish Public Safety and Court Officials this last week. The head of the Polish Police, the International Affairs Division, as well as the Chief Prosecutor for the nation of Poland visited Tempe to better understand the realities of combating certain problems in our country. She also thanked City employees for suggestions offered regarding the budget. Many of the employees have expressed great understanding of how difficult these days are for decision-makers, and she thanked them for that. Two events are coming up: A concert for the Tempe Youth Wind Symphony will be held April 1st at 7:30 p.m., at the Tempe Center for the Arts, and "Music Under the Stars" will be held on April 17th at 7:30 p.m.

- Councilmember Woods also congratulated Councilmember Arredondo. He also noted that balancing the budget has been a difficult job, and he thanked residents for their support.
- Mayor Hallman added his congratulations to Councilmember Arredondo. He also stated he was disappointed with the City's process regarding the bus contract. The basis on which we completed this process was distressing. When we are awarding a contract that is for \$100M, to have but 10% of the weighting based on the pricing we would receive is peculiar. There were other elements in it that he was very concerned about and it is not a reflection on our current contractor, but on our way in which we conducted business. He hoped we would do better next time.
