**FISCAL NOTE:** There should be a modest increase in Parks and Recreation's total revenue resulting from the proposed changes.

**ADDITIONAL INFO:** The City Council approved a fee policy for Parks and Recreation programs and services in 1992. The policy is on file with the City Clerk. Incremental adjustments have been made, as necessary, and as approved by the City Council with recommendations made during the 2006 budget process as approved by council. Staff recommendations made during recent budget processes as approved by council are included in this update.

With the proposed ramada fees, non-residents will be able to reserve park ramadas. Tempe residents may reserve ramadas up to 11 months in advance and non-residents up to 3 months in advance.

**RESOLUTION NO. 2008.91**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, ESTABLISHING FEES FOR THE PARKS AND RECREATION PROGRAM.**

WHEREAS, the City of Tempe has an established parks and recreation program for its citizens, and

WHEREAS, as a part of this program certain recreational fees must be charged in order to recover costs and provide the service and

WHEREAS, the City Council has considered a policy for charging fees that is based on the type of service and

WHEREAS, the City Council has previously approved fee policies established for the Parks and Recreation Department and filed with the City Clerk

NOW, THEREFORE, be it resolved that the City Council of the City of Tempe adopts Resolution 2008.91 which shall amend the fees previously set for parks and recreation programs as follows:

**4.1 Amplified Music Permit**

Permit \$ 2 5 per day

**4.2 Ball Field Reservation Permit**

Daytime  
Reservation \$ 7 20 per two hour block

Nighttime  
Reservation \$ 20 30 per two hour block

**4.5 Beer Permit (AVAILABLE TO TEMPE RESIDENTS ONLY. Valid only until dusk – unless it is part of a facility reservation.)**

Permit \$ 2 10 FOR ALL PARK LOCATIONS WITH THE EXCEPTION OF THE ENTIRE FIESTA RAMADAS, RUBEN ROMERO CORPORATE AREA AND SISTER CITIES GARDEN per day
