Agenda Item 3 – Girls for a Change

Girls for a Change is a national organization that empowers girls to create social change. Laura Valdo is Executive Director of Girls for a Change. While the organization is based in San Jose, CA, they are also active in 30 schools in Maricopa County and this is the first year they have had a Tempe presence (at

Fees Middle School). The program is open to girls ages 11-18. The girls are placed on Action Teams and paired with professional female coaches. Together they identify a problem in their community and come up with a solution or action to address the problem. Girls for a Change relies on community involvement and support. The organization is hoping to build a larger presence in Tempe and increase community awareness. Commissioners Arlene Chin and Linda Ritland both provided suggestions to Laura for contacts in the community.

Agenda Item 4 – Farewell to Commissioner Zubair

Chair Colleen Byron first welcomed new Commissioner Josephine Vega. Chair Byron thanked Commissioner Muhammed Zubair for his service on the commission. She shared that she believes Muhammed was an important member of this commission. He spearheaded the Diversity Supplier Program for the city and always brought a voice and perspective to the commission that is vital and very much appreciated. Commissioner Zubair spoke that he is humbled by the kind words of Chair Byron. He recounted past meetings and issues addressed by the commission and stated he feels positive about his contributions.

Agenda Item 5 – Water Department Pending Litigation: Ernie Calderon Report

Commissioner Truxon posed the question of why this group of employees either did not know or did not feel comfortable coming to the commission with their issues. He also stated that he was concerned about the process and questioned who is responsible for the process. The commission is currently working on making themselves more visible to both the community and the workforce. This situation validates the need to further this initiative.

City Manager Charlie Meyer stated that although he can not speak about the pending Ernie Calderon report as the report is not yet available, he can speak to his perception of the situation. He felt it was in the best interest of the city to contract an outside agency to conduct this investigation based upon the multiple issues involved including an allegation of ostracism and retaliation against 1 or more employees and a grievance filed by supervisory and administrative staff against another department in the city. This investigation has proven much more complex than originally perceived. Mr. Meyer stated they are now waiting for the report to be released and hopes that it will be clear as to what the root causes of these issues are. He briefly shared his understanding of the employee relations issues with the Water Department, including an incident in September 2007 in which several employees were exposed to hazardous chemical fumes.

Commissioner Arlene Chin asked if there is a history of issues with these employees or is it just the isolated September 2007 incident? Mr. Meyer responded that there is a long history of employee relations issues, but he believes the September 2007 incident exacerbated the existing issues.

Commissioner Gail Paredes-Ewen asked if any preliminary actions have been taken or are you waiting for the Calderon report? Mr. Meyer responded yes, several actions have already been taken, particularly regarding any safety issues at the treatment plant. In addition, Assistant City Manager Jeff Kulaga and he have been personally involved in the management side as well.

Commissioner Patricia Young asked if any of the issues have been based upon race, gender or age? Mr. Meyer responded that one incident was gender based but he doesn't believe that is the only issue.

Chair Byron thanked Mr. Meyer for attending and sharing his perspective of the situation with the commission. She will place this issue on the January agenda for a follow-up discussion.

Agenda Item 6 – HRC Retreat Discussion

Chair Byron questioned if the group still wanted to go ahead with the planned strategic planning retreat given that elections will be next month and a new chair would be elected. After much discussion, the commission decided to proceed with the scheduled retreat but to narrow their focus to visibility both in the work force and the community and to discuss the Ernie Calderon report. The retreat is scheduled for Monday, December 1st, 2008 7:30am – 8:30am.

Agenda Item 9-Current Events Announcements


The next GSA meeting is scheduled for November 19th. There is GSA social event scheduled for November 12th at 5:30pm at LaBocca on Mill Avenue.
