**RESOLUTION NO. 2009.67**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, EXTENDING THE TERMINATION DATE OF MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY AND THE TEMPE SUPERVISORS' ASSOCIATION WITH EXCEPTIONS.**

WHEREAS, the City of Tempe ("Tempe") and Tempe Supervisors' Association ("Union") have entered into a Memorandum of Understanding ("MOU") for the period of July 1, 2007 to June 30, 2009;

WHEREAS, on January 8, 2009, the Tempe City Council entered a Resolution (the "Resolution"), in which the parties acknowledged Tempe's belief that it was experiencing a "fiscal crisis" and the parties agreed to suspend certain benefit provisions of the MOU until the "fiscal crisis" subsided;

WHEREAS the parties are currently negotiating the terms of a new agreement, and have determined that it is in their mutual interest to continue those negotiations beyond the June 30, 2009 expiration of the MOU; and

WHEREAS the parties believe it is in their mutual interest to continue to operate under the provisions of the MOU, with the modifications set forth below, until the parties reach a final agreement on a new MOU.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA, as follows:

1. The parties agree to extend the termination date of the MOU from June 30, 2009 to September 30, 2009 (the "Extension Period"), or to such time when a new MOU is ratified by the City Council, whichever comes first.

2. During the Extension Period, the parties agree that the Market Adjustments provision set forth in Article 6.2 of the MOU shall continue to be temporarily suspended and voided as provided in the Resolution.

3. Also during this Extension Period, the parties agree to temporarily suspend and void the Step Increases provision set forth in Article 6.1 of the MOU.

4. The parties stipulate that nothing in this Agreement, other than that described in the paragraphs above, alters or amends any rights or obligations established in the MOU and that any alleged breach or impasse of this Agreement shall be resolved as provided for in the MOU.
