RE: SACA Grants: Summer and Special Collaborative Initiative
Recommendations

On June 5, 2008, during the City of Tempe Issue Review Session, TCC will make a presentation for the annually awarded Seized Asset for Community Action (SACA) Summer Grant program (also known as the mini-grant program).

TCC will also present three options for City Council consideration regarding the one-time award for the SACA Special Collaborative Initiative Grant program. These options are:

Option No. 1: Funding new innovative programs as well as effectively addressing current identified needs.

Option No. 2: Funding new innovative programs, effectively addressing current identified needs, as well as, strengthening existing programs that are currently advancing the RICO and SACA goals.

Options No. 3: Alternative option offered by City Council.

Please note that all programs that within TCC's recommendations have been reviewed by the Tempe Police Department Legal Advisor. After City Council approves funding recommendations, the Tempe Police Department will submit the final requests to Maricopa County for final review and approval for funding under the current RICO statutes. Upon approval, the Police Department will authorize payments to award recipients. TCC will continue to monitor the services provided by awarded agencies.
