Jayson Matthews called the meeting to order at 7:31 a.m.

Agenda Item 1 – Consideration of Meeting Minutes

Don Cassano made a motion to approve all minutes. Steven Saiz seconded the motion. The following minutes were approved as submitted:

Agenda Item 2 – Public Appearances

There were no public appearances.

Agenda Item 3 – Tempe South High Capacity Corridor Study Update

Dawn Coomer introduced Marc Soronson and Wulf Grote with Valley Metro who presented the following information:

- The cities of Tempe and Chandler began working with METRO on a 24 month study last summer, to analyze potential high capacity transit improvements.

- The study is being funded by local as well as regional sales tax
- They are currently in Tier one of the evaluation and analysis process
- As a result of two public scoping meetings held in January and early February, McClintock Drive BRT is being recommended for elimination as an alternative.
- Additional alternatives proposed for further analysis in Tier one include:
 - UPRR (Tempe Branch): BRT, LRT, Commuter Rail
 - Mill Avenue/Kyrene Road: BRT (fixed guide way), BRT (mixed traffic), LRT/Modern Street car
 - Rural Road: BRT (fixed guide way), BRT (mixed traffic), LRT
 - McClintock Drive: LRT
- Tier one is scheduled for public review sometime in April or May 2008
- Plan to report back to the commission after public meetings in early summer.

Agenda Item 4 – Light Rail Advertising Proposal

John Farry presented the following information:

- Current city of Tempe policy and Metro policy prohibits advertising in certain places like bus shelters, bus interiors etc.
- The use of advertising through the light rail system could off set some expenditures for the following:
 - Safety education program for light rail
 - Light rail grand opening event
- Suggestions for advertising included:
 - Use of one display case at light rail stations – estimated revenue \$145,000 – \$195,000 per year
 - Train wraps on 20% of fleet – estimated revenue \$625,000 – \$750,000 per year
- Proposed twelve month moratorium on the city's and Metro's current advertising policy to allow use of advertising in order to off set costs associated with grand opening and safety education program

Don Cassano motioned to not go forward with the proposal at this time. Amanda Ormond seconded the motion.

Agenda Item 5 – Professional Advertising Services

Sue Taaffe presented the following Public Involvement/Marketing Committee recommendation:

- To approve budget amount of \$383,000 to outsource next year's media placement buying to Off Madison Ave.

Don Cassano made a motion of approval. Kevin Olson seconded the motion.

Agenda Item 6 – Tempe Urban Space Study

Jayson Matthews opened the floor for input on the study. There was none.

Agenda Item 7 – Bus Stop and Pull-out Program Update

Marc Pearsall presented the following information:

- Six pull out bays are currently under design and should be complete by fall of this year
- Installation of 25 mini shelters will begin this summer
- Proposing an additional 15 standard shelters to be installed this year
- Tempe and ASU are partnering to install 25 new ASU designed shelters on campus
- Twenty-one "GREEN" shelters will be installed at major bus/rail transfer areas before the end of the year
